1. Minutes of the previous meeting could not be officially approved as it was not a quorate meeting.

- 2. Matters arising:
  - a. Sustainability Policy meeting still needs arranged by KM and FB (ACTION).
  - b. KM hasn't heard back from Leonie about moving the date of payment for rent of St. Mary's Field, will update at next meeting (ACTION). Still to do.
- 3. Special Meeting: FB raised the issue that we need to be clearer on where SK is going and what each committee member's role is, as well as liability including H&S, financial and risk. The committee voted unanimously in favour of an extended meeting of the full committee at 2pm on Saturday 8th January, to discuss SK matters including committee roles, goal setting for 2022 and what we have the capacity to deliver as an organisation.

- b. St. Mary's Field RW had several suggestions for ways to develop the field in the coming year. It was agreed these would be discussed by the new committee after the AGM (ACTION).
- c. Outdoor Tots Group ED noted the group is going well. So far 11 families have attended at least one session.

d. Future Kirrie – the full community meeting was held online due to Covid-19 cases being high. A recording of the presentation from the meeting is available on the SK website and YouTube channel.

The objective is to raise awareness of SK and encourage feedback from local people, particularly those who may not be active on social media. We will be looking for volunteers to distribute these in January.
